

# AutoShares Ghana – Terms & Conditions

Welcome to **AutoShares Ghana** (also referred to as “AutoShares,” “we,” “us,” or “our”). These Terms & Conditions (“Terms”) govern your access to and use of the AutoShares platform, including our website, mobile application, and related services (collectively, the “Platform”).

By accessing or using AutoShares, you agree to be bound by these Terms. If you do not agree, please do not use the Platform.

## 1. About AutoShares

AutoShares is a peer-to-peer car-sharing platform that connects vehicle owners (“Hosts”) with individuals or entities seeking to rent vehicles (“Renters”) in Ghana.

AutoShares does **not** own, maintain, or operate vehicles listed on the Platform unless explicitly stated.

## 2. Eligibility

To use AutoShares, you must: - Be at least **21 years old** (or as otherwise specified) - Hold a valid Ghanaian or internationally recognized driver’s license - Have legal capacity to enter into contracts - Provide accurate, complete, and truthful information

We reserve the right to approve, suspend, or terminate accounts at our discretion.

## 3. Account Registration & Verification

Users must create an account to use the Platform.

You agree to: - Provide accurate personal and contact information - Keep login credentials confidential - Notify AutoShares immediately of any unauthorized account use

AutoShares may require identity verification, driver’s license validation, or additional documentation.

---

## **4. Vehicle Listings (Hosts)**

Hosts agree to: - Own or have legal authorization to list the vehicle - Ensure the vehicle is roadworthy, insured, and compliant with Ghanaian laws - Provide accurate vehicle descriptions, availability, and pricing - Maintain the vehicle in safe operating condition

AutoShares may remove or suspend listings that violate these Terms.

---

## **5. Bookings & Use of Vehicles (Renters)**

Renters agree to: - Use vehicles only for lawful purposes - Return vehicles on time and in agreed condition - Not sublease, misuse, or allow unauthorized drivers - Follow mileage, location, and usage restrictions

Late returns, damage, or violations may result in additional charges or penalties.

## **6. Payments & Fees**

- All payments must be made through the AutoShares Platform
- AutoShares charges service and/or transaction fees
- Prices, fees, and commissions will be clearly disclosed

Refunds, cancellations, and disputes are subject to the applicable cancellation policy.

---

## **7. Insurance & Liability**

Insurance coverage may be provided through third-party partners or required of Hosts.

AutoShares: - Is not an insurer - Does not guarantee coverage for all incidents

Users are responsible for understanding applicable insurance terms and liabilities.

---

## **8. Damage, Accidents & Claims**

In the event of damage, theft, or accident: - The incident must be reported immediately to AutoShares - Users must cooperate fully with investigations - Repair, replacement, or liability costs may apply

Failure to report incidents may result in account suspension.

---

## 9. Ratings, Reviews & Conduct

Users may leave reviews and ratings.

You agree not to: - Post false, misleading, or abusive content - Harass, discriminate, or threaten others

AutoShares may remove content or suspend accounts for misconduct.

---

## 10. Prohibited Activities

Users may not: - Provide false information - Circumvent platform fees - Use vehicles for illegal activities - Interfere with platform operations

Violations may result in immediate termination.

---

## 11. Suspension & Termination

AutoShares may suspend or terminate accounts without notice if: - These Terms are violated - Fraud or safety risks are identified - Required documentation is not maintained

---

## 12. Limitation of Liability

To the maximum extent permitted by law: - AutoShares is not liable for indirect, incidental, or consequential damages - Use of the Platform is at your own risk

---

## 13. Indemnification

You agree to indemnify and hold AutoShares harmless from claims arising from: - Your use of the Platform - Vehicle misuse - Breach of these Terms

---

## 14. Privacy

Your use of AutoShares is subject to our **Privacy Policy**, which governs how we collect and use personal data.

## 15. Governing Law & Dispute Resolution

These Terms are governed by the laws of the **Republic of Ghana**.

Disputes shall first be resolved amicably. If unresolved, disputes may be submitted to Ghanaian courts or arbitration.

AutoShares may update these Terms at any time. Continued use of the Platform constitutes acceptance of revised Terms.
